You may receive a greater tax benefit from a gift of stocks or bonds. If the value of your securities you owned for more than one year has increased, you may avoid capital gains tax and receive a charitable income tax deduction equal to the fair market value of your gift.



### PLANNED/ESTATE GIVING

Your gift can be included as a bequest in your will or living trust.
